## **Officers' reports:**

<u>President</u> (Carolyn Cordray) Gave brief overview of the previous evening's Township Trustees meeting; advised that Bryan Rhodes has taken on additional job duties to fill the newly created Township Administrator position. Discussion was had on Ridgewood Park issues; unkempt areas, tagging, mounds of dirt, and downed ash trees, etc. Concern and costs of lighting the cemetery flag was also addressed as was the issue of painting house numbers on curbs, related costs and reminder that the code is specific in what home owners are to provide in the way of size and color of house numbers. It was suggested that the issue also be addressed in The Herald.

There were 8500 hits on the Huber Ridge website, and we currently have 96 members on the Huber Ridge Facebook page.

<u>Vice president</u> Eric Cordray was not present; however Carolyn advised that the neighborhood garage sale date is June 23 this year. If anyone has ideas for speakers, please contact Eric.

#### Secretary none given

<u>Treasurer</u> (Pam Clegg) Reviewed report (attached) of expenses and current Association balance. She has obtained the EIN number for the HRAA and is investigating changing banks if Fifth Third is unwilling to give us free checks.

<u>Immediate Past President</u> (Jim Welch) Updated us on status of Ohio American Water's rate increase; staff report is complete, OAW wants a 26% increase, staff report recommends 9%. Information about public hearings will be published when available. Buyout of OAW will be complete in about two months.

Ann Gonzales advised Jan Heichel that HB 379 has been pulled from the agenda due to lack of public response in opposition. Will advise if it is added to agenda again. OAW can oppose if they wish.

### Board and committee reports:

<u>Newsletter</u>: Marje distributed a newsletter report (attached) with the list of possible articles/writers for the next issue. Almina advised that she needs more folks to help distribute The Herald.

<u>Membership</u>: Joy prepared and distributed a membership report (attached) which also included information on homes sales in the area. She also updated us on plans for the Silver Celebration and Ridge-a-Palooza. Thom provided a report of progress in membership renewals (attached).

<u>Block Watch</u>: Doug gave an update on crime reports received through the Blendon Township Police Dept. His report is attached.

Drawing was held for the "Household of the Quarter" for the spring edition of The Herald. Three names were selected and Joy will contact them in order of the names drawn to see if they are interested.

### New business:
