RECOMMENDATION: The Huber Ridge Area Association Executive Committee recommends to the general membership that we re-organize the structure of our association by:

- ➤ Changing our designation to an incorporated non-profit corporation
- File Articles of Incorporation as a non-profit 501 (c) (4) group with the Secretary of State at a one-time cost of \$125.
- Register our association name with the Secretary of State as a trade name for a cost of \$50, then every \$25 every five years for a renewal fee.
- ➤ Attorney, Fred Milligan's fee for consultation and handling our paperwork for a cost of \$125

BACKGROUND: The HRAA has been operating as an unincorporated association since its reorganization approximately 7 years ago. Compare then to now:

Then: Now:

20 or so member households 220 member households

Organized a few events

Largest attendance at events: 75

Annually coordinates several events

Largest attendance at events: 400+

Bottom line, we've caught on in the neighborhood!

## WHY WILL THIS BENEFIT THE HRAA?

- ➤ 501 (c)(4) is an IRS classification for civic leagues and social welfare organizations that are not organized for profit. This designation will allow the HRAA to apply for recognition of exemption from federal income taxes.
- Taking these steps to re-structure our organization which has grown significantly over the years will provide liability protection as a corporation we currently don't have as an unincorporated association for individual members.
- ➤ Registering our association name with the Secretary of State as a trade name protects our exclusive right to the use of our association name.

## **NEXT STEPS:**

- Review proposal and research to make your personal determination as to the direction the association should take.
- ➤ At the May 3<sup>rd</sup> general meeting of the HRAA we will vote on this issue. Please plan to attend!
