Issue #37—Proposed Zoning Plan

A Zoning Department Is Up for Your Vote on Election Day, November 5

The Blendon Township Trustees have been working toward creating a Blendon Zoning Department. On November 5, 2013, residents vote on this topic. Currently, all zoning matters in Blendon Township are handled by three Franklin County Commissioners, who have a very large area to evaluate. Having our own Zoning Department would give Blendon Township the ability to make decisions on their own local matters instead of having County officials decide for them. Blendon Township officials would be able to respond faster than Franklin County to our residents' requests.

Earlier this year, the Trustees created the Blendon Township Zoning Commission, which was comprised of volunteer Blendon residents, the Township Administrator, and legal counsel. This committee reviewed and suggested changes to the current Franklin County Zoning Code. The Commission's goal was to protect the environment, maintain the integrity of existing neighborhoods, and encourage quality improvements consistent with the wishes of our residents. This would make the code a better fit for Blendon Township (instead of the current code that covers all of Franklin County). The Township's Zoning Commission developed a zoning code. This zoning code will ONLY be implemented if residents vote in support of Issue #37. The proposed zoning code and related map can be found online at blendontwp.org.

Important Facts:

- Local zoning would **NOT** increase taxes.
- Revenue from inspections and permits would go to Blendon Township instead of Franklin County.
- The proposed zoning would not change the current zoning of any property in Blendon Township.
- Bringing zoning to a local level would enhance services and enable the Township to rebuild at a better pace.
- Township officials would be able to respond more rapidly to complaints.

- Local zoning would allow faster response to renovation and new development opportunities.
- The Smart Growth Overlay would be removed from the current zoning code to encourage businesses to redevelop in Blendon.
- The Alum Creek and Big Walnut Overlay would be modified to protect homeowner rights and interests in their land—yet remain sensitive to environmental factors.

Neighbor News

"At Last" was one of the beautiful songs sung and played by Hang Time at the second Concert-in-the-Park in our Ridgewood Park on July 13 at our great new gazebo.

Because of the dedication and hard work of so many the Huber Ridge Area Association, Inc.; the Boy Scouts, the Little League Baseball; WARM; numerous residents; the Township Trustees; and Township grants, our park is absolutely beautiful!

Perhaps you are unaware that Ridgewood Park did not start to become a reality until 1972 when additions were implemented to accommodate the community; i.e., playground equipment, shelter house, etc. Let me share some history with you.

It seemed we had just successfully completed Operation Traffic Light when I was approached by original residents, the Haffners of Stockholm Road, who stated, "Now we need a park and/or a recreation program for the ever increasing number of children in our area."

In November 1971, we started with a meeting in my home with key individuals: the Township Clerk; the President of the Civic Association; the President of the Westerville Area Civitan; the Huber Ridge PTA; representatives of each area in Huber Ridge, Glengary, Fox Chase, and Hunt Club; and Dick Rano, Recreation Director for Westerville. The Westerville Area Civitan, the Huber Ridge PTA, and the Huber Ridge Civic Association each donated \$300—thus making \$900 to start the first recreation program. The Blendon Township Trustees helped to finance the needed equipment and to pay the hired co-directors. We were allowed to use the Park as well as Huber Ridge School grounds. Proper insurance was arranged, volunteer parents worked with the directors, the Girl Scouts served as baby sitters

for the volunteer parents, and the men were trained by a naturalist from the Columbus Metropolitan Parks to conduct nature walks.

Once again, the community came together; and with much planning and preparation and man hours, the first recreation program began the summer of 1972! It was so well attended that starting the next year our area was included in the Westerville Recreation Program!

I am very proud to have been instrumental in its beginnings and so grateful to all who have made it possible for our park to continue to thrive. We have something wonderful ... "At Last."

Long-time resident Ron Fultz of Oslo Drive participated in this year's WesterFlora. He was awarded a blue ribbon for the most extensive variety of flowers. Congratulations!

A number of Huber Ridge residents came together to observe the 30th anniversary of National Night Out on Tuesday, August 6. We had three of the remaining original residents of the Ridge-Walt Kelly, Tom Carlson, and Almina Smock-Wiebell—on hand. Blendon Township Trustee Jim Welch and his wife, Jean, joined us along with Doug Murphy, our Block Watch Coordinator, and his wife, Diane. The Pitneys and their two sons came out to be with us as well. We are grateful to Bryan Rhoads, Blendon Township Administrator, for taking time to talk with us and bring us up to date on upcoming Blendon Township endeavors. Many thanks to Sharon Ricker and Tom Wiebell for arranging and hosting the get-together.

Burke's Blades

Maybe you thought you needed to buy a new knife or tool. Well, save that money and get your knives and tools sharpened instead for a lot less. As Tom said, "A sharp knife is a safe knife. It's a dull knife that can cause more damage." So it's really important to have our knives and tools with blades sharpened from time to time.

Gather up your dull knives and tools and visit Tom located at 5544 Oslo Drive here in Huber Ridge. Tom works out of his garage and can also come to your home to sharpen your knives, tools, and mower. 

An Extremely Frightening Experience ...

The other day I had an extremely frightening experience in our neighborhood. A young child on a motorized scooter pulled out in front of my large sized vehicle. The child was not wearing a helmet, ran through a stop sign, and was happily riding in the road—oblivious to oncoming traffic. I slammed on the brakes, and both of us were visibly shaken.

In Ohio, motorized scooters cannot be legally operated on public roadways unless they are titled, registered, insured, and operated by a properly licensed rider at least 16 years old. The motorized scooters that are typically bought in sporting goods stores or department stores cannot be titled or registered, which means they cannot be driven in the streets or roads in our neighborhood.
